Emergencies Happen

An ambulance transport can cost between \$400 and \$1500. Most insurance providers, including Medicare, expect you to pay 20% or more of the ambulance bill. Our program works like a supplement to your existing insurance or Medicare/Medicaid, or fills the financial gap if you don't already have insurance. As a member you won't have any surprise when it comes to your ambulance bill.

Act Now

Join Ada County Paramedics Neighbors for Life today. Your \$60 membership will pay for all family members in your household for a year. You simply complete the application, pay your \$60 membership fee, and your entire household is included. Your insurance will be billed, but you pay no more than \$100.

*Additional funds beyond \$60 will be considered a donation to your local EMS Service.

How the Plan Works

When you have a medical emergency that requires ambulance transport to the emergency room, you and your insurance company are billed for the treatment and transportation Ada County Paramedics provide.

If you are a Neighbors for Life Member and have an emergency that requires medically necessary treatment and transport to an emergency room, you never pay more than \$100.

Statement of Understanding

1. I understand that the Ada County Paramedics Neighbors for Life (N.f.L.) Membership program benefits me, my spouse and anyone who can be claimed on my tax return.
2. My member benefits take effect 48 hours after my payment and complete enrollment form are received by Ada County Paramedics.
3. I understand that N.f.L. is not an insurance but is in addition to and secondary to any insurance or medical benefits I may have.
4. N.f.L. applies only to 9-1-1 emergency medical services (EMS) only, not non-emergency transfer services.
