

RESOLUTION NO. 1414

AT A MEETING OF THE BOARD OF ADA COUNTY COMMISSIONERS, STATE OF IDAHO, ON THE 22nd DAY OF AUGUST, 2006, THE FOLLOWING RESOLUTION WAS UNANIMOUSLY ADOPTED, TO WIT:

WHEREAS, the Ada County Board of Commissioners is authorized pursuant to I.C. § 31-870, Fees for County Services, to impose and collect fees by resolution; and,

WHEREAS, the County Surveyor and the Director of Development Services recommend that the Board of Ada County Commissioners amend the Schedule of Surveying Fees to cover direct costs; and,

WHEREAS, the Schedule of Surveying Fees, which was previously part of the Engineering Fees, has not been amended since July 5, 2005; and,

WHEREAS, the Board of County Commissioners has reviewed the need to increase the fees to cover the direct costs of review and verification of subdivision and condominium plat/declaration, re-review declaration and reverification of subdivision and condominium plat/declaration; and,


WHEREAS, such fees shall be in an amount reasonably related to but not exceeding the costs of such services;

NOW THEREFORE BE IT RESOLVED that the schedule of amended Schedule of Surveying Fees attached hereto as Exhibit 'A' shall be effective on the 1st day of October, 2006.

APPROVED AND ADOPTED by the Board of Ada County Commissioners this 22nd day of August, 2006.


